Proactive Collections Will Continue

HOA dues are essential for maintaining our community common areas, making improvements, and meeting our recurring financial obligations. All HOA dues must be paid to maintain their affordability and fairness for all. If you are delinquent with your dues, you can expect to experience con-

tinued proactive collection efforts in 2016. Our proactive collection efforts on delinquent accounts will inevitably have an adverse effect on an affected member's credit. Consumer credit status is used by many organizations these days from background investigations for employment, to home and auto

insurance. On April 26, 2016, the Board voted to continue to aggressive collections including pursuing foreclosure proceedings on any homeowner who has refused to pay and/or make arrangements to pay delinquent dues greater than 5 years.

Be Prepared for Disasters

After a major disaster the usual services we take for granted, such as running water, refrigeration and telephones, may be unavailable.

Experts recommend that you put together an emergency kit and go-bag with some basic items sufficient for at least three days, for example:

 Water—one gallon of drinking water per person and per day, and rotate every 6 months.

- Food—ready to eat or requiring minimal water, such as: canned tuna, canned fruits and vegetables, canned beans, raisins, peanut butter, granola bars, canned milk.
- Manual can opener
- First Aid Kit
- Battery operated radio
- Unscented liquid household bleach for water purification
- Blanket or sleeping bag
- Cash in small denominations
- Large plastic bags for waste

- Warm clothes, hat, rain gear
- A local map
- Hygiene items, toilet paper etc.
- For your pets, drinking bowls, food, cat litter, veterinary records

What should I do to protect myself from the Zika virus

Cover up and use bug spray, for starters. Preventing mosquito bites is the best way to prevent Zika, and while that may seem obvious, it can take some work. According to the CDC, use insect repellants that contain one of the following ingredients: DEET (20% to 30% concentration is best, according to the CDC), picaridin, oil -of-lemon eucalyptus, paramentane -diol or IR3535. You should make sure your windows have screens and the air conditioner is on if you're home during the day; the mosquitoes that spread Zika are day biters. And since a mosquito needs only a tiny bottle-cap size pool of water to lay as many as 200 eggs, you should remove any type standing water around your home.

Value Added With Property Upkeep

Just like your need for an annual physical at the doctor's office or your automobile's need for a tune up and oil change, you should rely on a professional to give your home regular checkups. Proper upkeep can protect against costly future ailments, enhance curb appeal, ensure safety and maintain the value of your home. For example if your windows are not properly caulked, water could get into your sheathing, causing mold and rot. Next thing you know you are looking at a \$5000 repair instead of spending \$75 to have a professional caulk.

Home maintenance will affect your property value. If you neglect to take proper care of your home you can expect damages to occur and an overall property value decrease. Most realtors will tell you that if you go to sell your house and it is in "worn condition" (disrepair) you can expect to lose around 10% of its appraised value. On a \$250,000 home, this would amount to \$25,000. We all know that curb appeal is an important factor in helping our house sell. If you have faded paint and rotted siding this is not going to be appealing to the prospective buyer. So, moral of the story is spending a little bit of time and money each year on home repairs and maintenance will help you save money and make more money in the long run.

City of Bartlett, Code Enforcement Compliance

Inoperable Vehicles

Definition: A vehicle which cannot be driven upon the public streets for reasons including but not limited to being unlicensed, wrecked, abandoned, in a state of disrepair, or incapable of being moved under its own power.

No inoperative or unlicensed motor vehicle shall be parked, kept or stored on any premises, and no vehicle shall at any time be in a state of major disassembly, disrepair, or in the process of being stripped or dismantled

Grass/Weeds/Shrubs

All premises and exterior property shall be maintained free of weeds or grass in access of (9) inches. Upon failure of the owner or agent having charge of a property to cut, edge or weed eat the overgrown grass and/or weeds after service of a

notice of violation, and action or repairs taken by the authority having jurisdiction on such premises shall be charged against the real estate upon which the violation is located and shall be a lien upon such real estate taxes. Failure to comply with the notice of violation, may result in an authorized city employee or city contractor to cut the overgrown grass and weeds and bill the homeowner.
