If you are delinquent with your dues, you can expect to experience proactive collection efforts in 2016. Our proactive collection efforts on delinquent accounts will inevitably have an adverse effect on an affected member's credit. Consumer credit status is used by many organizations these days from background investigations for employment, to home and auto insurance. Please do not risk adverse actions to your valuable credit. Value Added With Property Upkeep

Just like your need for an annual physical at the doctor's office or your automobile's need for a tune up and oil change, you should rely on a professional to give your home regular checkups. Proper upkeep can protect against costly future ailments, enhance curb appeal, ensure safety and maintain the value of your home. For example if your windows are not properly caulked, water could get into your sheathing, causing mold and rot. Next thing you know you are looking at a \$5000 repair instead of spending \$75 to have a professional caulk.

Home maintenance will affect your property value. If you neglect to take proper care of your home you can expect damages to occur and an overall property value decrease. Most realtors will tell you that if you go to sell your house and it is in "worn condition" (disrepair) you can expect to lose around 10% of its appraised value. On a \$250,000 home, this would amount to \$25,000. We all know that curb appeal is an important factor in helping our house sell. If you have faded paint and rotted siding this is not going to be appealing to the prospective buyer. So, moral of the story is spending a little bit of time and money each year on home repairs and maintenance will help you save money and make more money in the long run.

Home Fire Protection Reminder

Although I have mentioned this subject in a previous newsletter, with winter and the holidays approaching and the associated increased activities, I thought it would be a good reminder that the Home Safety Council reports the third leading cause of unintentional home injury and related deaths is caused by fire and burns. Just to name of few tips:

◆ Always stay in the kitchen while cooking

- •Store matches and lighters in a locked cabinet, out of the reach of young children
- ◆Keep things that can burn away from your fireplace
- ◆If you or someone in house smokes, use large, deep ashtrays on sturdy surfaces
- ♦Blow candles out when adults leave the room
- ◆Install smoke alarms on every level of your home and in every bedroom and practice family fire

drills

- ♦ Make a fire escape plan for your family. Very important if you have young children
- ◆Teach your family to "Stop, Drop, Roll and Cool" if clothes catch fire
- ◆Keep grills at least 10 feet away from the other objects
- ◆ Consider having a fire extinguishers, stored in multiple places around the house.
